More about the elections:

Three representatives will be elected for each of the 5 regions in EuroSIDA (Northern, Western, East Central, Eastern and Southern Europe [including Argentina and Israel]).

Elections are electronic and REDCap ballots will be available from **15th June until 1st July 2017**. The candidate's motivation letters will be circulated to all principle investigators.

There is no limit to the number of nominees in each region, and more than one candidate from each country may run for the steering committee. However, **only one candidate can be elected per country.**

We expect that all nominees are willing to:

- Participate in approximately six teleconferences per year in addition to one annual F2F meeting at a major European HIV conference
- Review abstracts, presentations and manuscripts
- Review project proposals
- Help ensure that EuroSIDA continues to have a competitive and clinically relevant research agenda
- Contribute energy, enthusiasm and willingness to drive the future research agend

Southern Europe: Spain, Portugal, Italy, Greece, Israel, Argentina based on the person-years of follow-up (PYFU) they have submitted since 2014. Sites contributing <2% of the total PYFU since 2014 have been awarded 1 vote, and sites contributing ≥2% of the total PYFU after 2014 have been awarded 2 votes. The election is anonymous and handling of votes and center ID is not passed on to the coordinating staff nor to the SC. The elected SC will be announced to all investigators shortly after the elections.

The steering committee constitutes itself at the first EuroSIDA SC meeting following the elections. To ensure hand-over, there will be a transition period until 1st January 2018 in which both current and new SC members participate in SC meetings.
